The Deerfield Township Fire Rescue Department accepts applications year round to fill vacancies which may occur in our part-time ranks. Our hiring processes are routinely conducted on a quarterly basis. Applicants are required to have a minimum of two years of experience working part-time in the fire services to apply or once hired, the applicant must successfully complete our recruit class.

All part-time employees must work either a 24 hour shift every 6 days or a 12 hour shift every third day. All applicants must have the following certifications from the Ohio Department of EMS:
