

2022 Mid-Year Report

DEERFIELD TOWNSHIP



Planning and Zoning

- Issued 172 zoning certificates (111 residential and 61 commercial). Approvals include: new homes, accessory structures, signage, additions, and interior/exterior modifications.
- Performed final inspections on 8 residential properties and 1 commercial property for zoning compliance with approved plans.
- Received 25 formal complaints and investigated 10 in the 2nd Quarter which resulted in 21 violation notices being issued to property owners.
- The Board of Zoning Appeals reviewed three (3) cases in the 2nd Quarter. Two (2) of the variances involved residential properties (one for an accessory structure and one for a setback on an addition) and the third (3rd) variance was to allow Freddy's Steakburgers to create a parcel without frontage along a public street.

- The Zoning Commission reviewed two (2) cases in the 2nd Quarter. The most significant review was review and a favorable recommendation to the Township Board of Trustees on the 2022 Comprehensive Plan Update

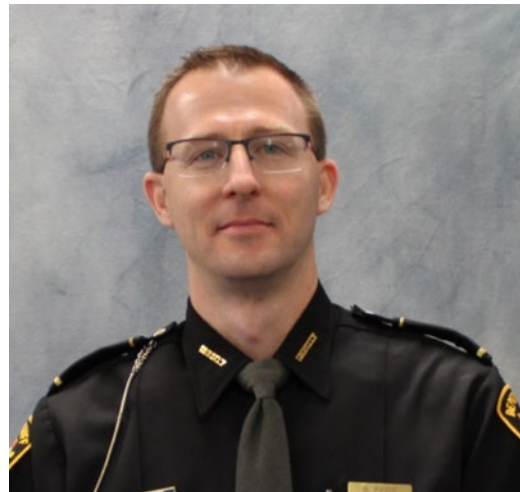
Warren County Sheriff

Completed selection process in early August for the agreed upon two new School Resource Officers for Kings Schools. Deputy David Sheppard and Deputy Phil Green join two existing School Resource Officers at the award-winning district.



Fire Department

Unit Two welcomed three new career Firefighter/Paramedics to our unit day at the end of the second quarter: FF/PM's Sam Queen, Chris Eisenecker, and Jared Drenik. We look forward to working with these three individuals for many years to come.

Our vendor, Capital Electric, completed the installation of all preemption signals within the township. On April 13, 2022 Path Masters began to turn the signals on and complete the mapping. Mapping is the process of setting the light sequence once preemption is activated.

Horton programmed our six medic units to work with the Preemption system. As of this date, all vehicles and intersections are operational. In the second quarter we began to see reduced response times in our busiest areas of the township. We anticipate for these times to continue to drop as the mapping is "tweaked" based upon traffic flow.



Fire Department

Received two Requests for Qualification's (RFQ) for the training tower, and both companies submitted Request for Pricing (RFP) packets back to Hamilton Township. With the ongoing inflation crisis, bids were slightly higher than anticipated; however, the additional costs shouldn't be an issue to move the project forward. Both RFP's had a final delivery/punch-out date in late 2022 so we won't be utilizing the tower until spring for training evolutions.

Crews had the opportunity to conduct training at the old Best Way site prior to demolition. We spent two weeks on property conducting Engine Company training to include hoseline deployment and Ladder Company training to include search techniques and ventilation.



Fire Department

Received most of the portable equipment for the new engine. We are still waiting on all of the hose. This unit has begun production and we anticipate delivery in early October. Our 2022 pumper project is an identical twin to our 2021 pumper project that is currently assigned as Engine 56. This is invaluable to ensure standardization and continuity of operations.

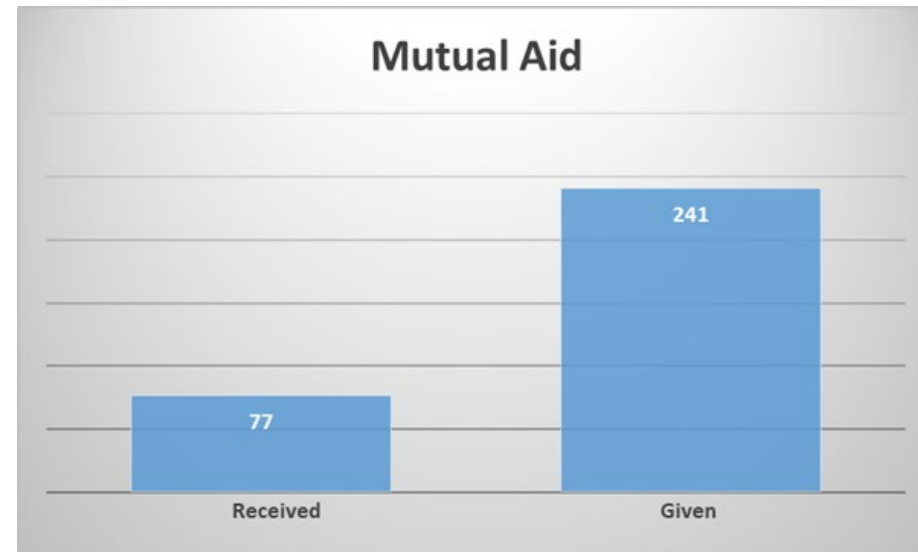
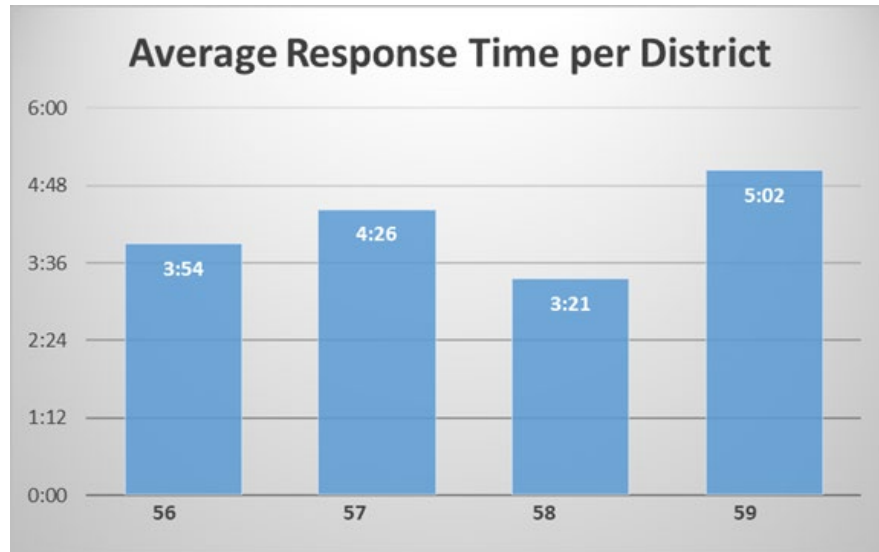

Road and Bridge Department

Quarter #2 milestones for the Service Department are detailed below.

Road Work

- Commenced monthly mowing and weed removal operations along all township roads and Parks during the 2nd quarter.
- Inspected and made necessary repairs/replacements in Sign Zones (4-6).
- Installation of all new signs on newly paved roads in 2022.
- Repaired/rebuilt all catch basins as needed during Q2.
- Completed culvert Pipe inspections for zones 4,5 and 6.
- Staff performed seven (6) sweeps of all zoning signs throughout the 2nd quarter.
- Service crew members chipped 520 yards of yard waste in quarter 2.
- Service Crew members assisted our cemetery with pouring foundations, also assisted with several Funerals.
- Completed our guardrail inspection, staff made all necessary repairs.
- Responded to all drainage issues, potholes, and other miscellaneous calls from residents.
- Completed the installation of new culvert pipes on Rich, Everett, Old Mill and Western Row Roads.
- Staff worked twelve (12) Township events April-May-June.



PW Administration

- Street Light Inspections – Staff inspected zones 3 thru 5 for defective street lights. 10 streetlights were reported to be repaired.
- 2022-01 Annual Resurfacing Project –Barrett Paving resurfaced 4.85 miles of roadway in Heritage Pointe, Chestnut Hill, Seilcrest Acres and Woodfield subdivisions. Curb, sidewalk, and roadway patching repair were included in this project. Punch list items are set to take place in July and August.
- 2019-03 Kings Mills Improvement Project – Barrett Paving completed Phase I in June. Punch list items to be completed this fall.
- Phase II easements have been sent out to residents. Bids were opened June 27, 2022. Upon reviewing the bid Ford Development Corp. is the lowest responsible bidder with a bid of \$ 2,534,043.30. Bid will be awarded at the July 5, 2022, Board of Trustees Meeting.
- 2022-02 Landscaping Maintenance Project – Degree Landscaping continues to check and maintain landscaped medians and welcome signs during their monthly visits.
- 2022-06 Kings Mills Phase II Tree Removal – A1 Tree Care successfully removed multiple trees and stumps in order for the utilities to be relocated.
- 2022-07 Sidewalk Replacement Program – Staff has been fielding, inspecting, and compiling a list of complaints regarding sidewalks that are in disrepair. Project is set to bid in September.
- Submitted documents to OPWC for Phase III Final and the Phase IV Pre-app for the Kings Mills Project.
- Continuing to collaborate with WCTID for the future construction of the pathway on Irwin Simpson, Western Row Safety Improvement and Columbia Rd. roundabouts.
- Completed safety training monthly for all service personnel.
- Working with Mercy Hospital and Danis to clean up underbrush and dead trees at station 58.
- Best Way Inn – project was 75% complete at this time. Needs topsoil, seed and straw.
- Staff continues to collaborate with Warren County Engineer's regarding the King Ave Turn Lane and Roundabout.
- Staff continues to work with Hudson Hills to address safety concerns. New signage, new pavement markings, and tree removal are improvements we are currently working on.



Deerfield Regional Storm Water District - Administration

- Staff fielded 92 storm water calls and received 12 Requests for Assistance (RFA) during 2022 Q2.
- Staff managed 14 stormwater related improvements, of which 8 projects were completed with another 6 in various stages of design or construction.
- The District submitted the 2021 Ohio EPA stormwater annual report. This report details the past years accomplishments and tracks the measures used to protect water quality and comply with EPA's permit requirements.
- The District has contracted with Strand Associates to study the drainage issues reported on Snidercrest Rd. They will present their findings and possible solutions at a board meeting during Q4.
- Strand Associates has also been selected to study flooding of the roadway and private property near the Meadow Dr. and Green Haven Way intersections. The results of the study are expected in Q4.
