Staff issued 122 zoning certificates (74 residential and 48 commercial). It should be noted that approvals include new homes, accessory structures, signage, additions, interior/exterior modifications, and Minor PUD Modifications.

Staff performed final inspections on ten (10) residential properties and two (2) commercial properties for zoning compliance with approved plans.

Staff received 28 formal complaints and investigated 23 in the 2nd Quarter, which resulted in 16 violation notices being issued to property owners. It should be noted that 5 of the formal complaints received were cleared prior to notices being issued, no zoning violation was found, and/or were non-zoning-related, and could not be addressed by the Planning & Zoning Department.



The Board of Zoning Appeals reviewed three (3) cases in the 2nd Quarter. Two (2) of the cases involved conditional uses and area variances for school properties, and the other case involved a commercial property. The most significant case was the approval of a conditional use and area variances for a new 290,000-square-foot high school on the Kings Local School District (KLSD) campus on Columbia Road.

The Zoning Commission reviewed three (3) cases in the 2nd Quarter. The most significant cases involved the Zoning Commission reviewing the proposed text amendments pertaining to Electric Vehicle (EV) Charging Stations and the text and map amendments pertaining to the implementation recommendations outlined in the Route 22 & 3 Corridor Plan. In both cases, the Zoning Commission recommended approval of the various amendments as presented.

Residential (Housing Starts)

There was a total of 25 zoning certificates issued to construct new residential dwellings (single-family detached). 



Quartermaster

There is not much new to report from the Quartermaster Group for the second quarter. Lt. Haines and FF Monroe continue to wear and evaluate the demo Innotex structural firefighting gear. As of now, no formal feedback has been received from either of them. The evaluation period will continue through the third quarter to determine whether the gear meets our standards for durability, safety, and cost-effectiveness for DTFR.

While Morning Pride remains the preferred gear among the majority of our crews, it is important that we continue to conduct thorough testing and evaluation of all available options. Our commitment to due diligence ensures we are providing our personnel with the best possible protection, performance, and value in the field.

Fire Equipment

The newly purchased Drager SCBAs went into service in June. All stations have been outfitted with the necessary tools and equipment to perform basic maintenance, as well as decontamination solutions for use after fire and hazmat incidents. While certified department technicians will continue to handle routine maintenance and address any issues that arise, crews are able to perform minor tasks—such as lubricating regulators and replacing batteries.

The only remaining Drager item we are currently awaiting is the confined space escape bottles. This delay does not impact our operations in any way. Once the bottles arrive, all members will receive the appropriate training to ensure proper use.

The SCBA repair room, along with the fire equipment room, has been fully revamped to improve functionality and efficiency. Both areas have been outfitted with new shelving, better organization systems, and a more structured inventory process. A more reliable backstock of supplies such as Halligan bars, hydrant wrenches, and nozzle parts has been established, ensuring quicker turnaround for repairs and minimizing downtime for some of the basic equipment carried.

These upgrades not only make day-to-day operations smoother for the Fire Repair group, and SCBA technicians, but they also provide station crews easier access to frequently used items. This investment in organization and readiness directly supports the department's commitment to operational excellence and safety.

Training

With the rollout of the new SCBAs, some adjustments were necessary to the training calendar during the second quarter. Both the June EMS training and the scheduled Fire training on standpipe operations were converted into company-level drills to allow for greater flexibility and focus on SCBA integration.

To ensure all personnel were fully familiar with the new equipment, Howell Rescue was brought in to conduct a comprehensive overview and address any questions. The following week, an SCBA competency drill was held in the apparatus bay at Station 57, where all department members—except those currently injured or on light duty—successfully completed the training. Those on restricted duty will complete the drill during their first shift back once cleared for full duty.

In addition, live burn training was conducted over three days during the first week of June. SCBA packs and spare bottles were also distributed to all stations to encourage continued hands-on practice, including mask-up drills and basic firefighting tasks. These efforts have ensured a smooth transition to the new SCBA system and reinforced operational readiness across the department.

The second quarter live burn with LSFD and the City of Mason was canceled due to multiple public relations events scheduled on their end. We currently have multi-company drills scheduled with the City of Mason toward the end of July, and our joint training with both LSFD and Mason is planned for September.



Township Trustees Seitz, Malhotra, and Hedding attended a groundbreaking for the new Kings High School. Plans for the new complex began more than a year ago after district taxpayers passed a bond issue for the project. Superintendent Greg Sears said the new building will provide much-needed space for students. The current high school is at 150% capacity. This project was a true community effort to add much-needed space for students and solve capacity issues. The new school will serve 1,700 students. It is expected to be completed during the 2027-28 school year.



In addition to the attraction and retention of business investment into the community, Township staff also develop programming designed to help existing businesses take advantage of opportunities for growth. Road and Bridge Department

This report highlights the key accomplishments of the Road Department during the second quarter of 2025.

Roadway and Infrastructure Maintenance:

- Mowing of all Township Roads completed as needed.
- Conducted comprehensive street sign checks in Zone 4-5-6.
- Completed saw cutting and curb work in the Trails Subdivision.
- Replaced storm pipe on Elm.
- Ditch work completed on Townsley, Locust and Ronbet.
- Installation of no Parking Signs in Elliot Farms.
- Addressed potholes and drainage concerns.
- Repaired seven failing catch basins.
- Provided maintenance assistance to the cemetery.
- Maintained township roads, including tree trimming along roadways.
- Removal of right-of-signs weekly.

Seasonal Programs:

• Seven residents utilized the debris removal program, our service department successfully.

Summer Operations Preparedness:

• Snow and Ice equipment inspected, and preventive maintenance process started.

Community Engagement:

- •Public Works Department staff assisted and worked at all Township events.
- •Service Department hosted JF Burns School for a field trip.



Public Works Administration

- Infrastructure Improvements:
- Street Lighting: Proactive inspections of Zones 3 and 4 identified eight defective streetlights, which have been reported for repair.
- Road Resurfacing Project: Barrett Paving Materials Inc. began work in March and completed various road patching and concrete curb and sidewalk repairs.
- The project scope was revised in May. Resurfacing will take place in July on various roads in Loveland Park, Rich Road, Gatsby Green, Strawberry Hill, and The Trails subdivisions, as well as on a portion of Davis Road and Western Row Road.
- Landscaping Maintenance: Degree Lawn and Landscape continued to make monthly visits for maintenance.
- Annual Street Marking Project: Staff opened bids on June 10th. The Aero-Mark Company was awarded the contract. Project commencement is estimated for late July.
- Streetscape Improvement Project: Phase II is being prepared to bid out later this summer. Waiting on permits from ODOT and review from WCWSD.
- Streetscape Improvement Project: Phase III is still in design phase.
- Carter Park Pathway Project: Continuing to work on easement work and engineering. (ODNR and Arcadis) will bid late summer.
- Western Row, Davis, Rich, and Primrose Improvement: Project underway should be completed in July.
- Township Safety Signage Grant: Grant documents prepared and submitted.
- Emergency Inspection and Cleaning at Swan Place: Initial work was completed in Q1, engineering underway for a new/better design.
- Western Row and Hudson Hills Roundabouts: Continuing to attend meetings with Engineering and City of Mason and WCEO.
- Myrtle/Davis Roundabout: Work was completed in May/June.
- Inspection for Kensington Subdivision: Phase I and Phase II
- Cox Smith Rd.: Met with WCEO to discuss and evaluate a storm pipe. Investigating the best solution.
- **Kings New School Road Improvement:** Kings Schools, WCEO, Deerfield Twp., and the City of Mason met to discuss any improvements, challenges or ideas surrounding the new school being built.
- Safety and Training
- Monthly safety meetings were held.



<u>Deerfield Regional Storm Water</u> <u>District – Administration</u>

Resident Service:

Responded to 84 resident inquiries and 9 requests for assistance (RFAs) related to stormwater issues.

Project Management:

Completed 3 stormwater projects and advanced 13 through various design or construction phases.

Infrastructure Improvements:

The District partnered with Deerfield Township to replace deteriorated culverts under Western Row Rd. as part of the annual resurfacing program. Replacing the culverts while the road was closed provided reduced delays for local drivers and was safer for the construction crews.

Engineering design is underway for improvements on Kingsley Ct. and Swan Pl. to alleviate flooding of roads and private property.

Construction should begin in the fall on a stormwater improvement project in the Country View subdivision. The project should help alleviate flooding of multiple properties and make the existing stormwater system easier to maintain.
