### Zoll Zenix Cardiac Monitor

Late last year, the EMS Division formed a cardiac monitor committee, consisting of two members from each unit, to help evaluate different cardiac monitors on the market. During the evaluation, Zoll Medical presented the group with a new cardiac monitor called Zenix, which was not yet available at the time of the evaluation due to pending FDA approval. After extensive evaluation and debate among the group, they decided to go with the Zenix monitor. We are excited to announce that we have received the new monitor late in the third quarter. Our department was one of the first to receive the new Zenix monitor nationwide. We, in the department, are excited to participate in the launch of the new monitor for Zoll Medical. Below are some features of the Zenix that led the committee to choose this particular monitor.

## **Noteworthy Incidents Unit Two Responded On During Third Quarter:**

- During the afternoon hours on 8/12/2025. Rescue 57 and Haz Mat 303 were dispatched as mutual aid into Union Twp. on northbound I-71 for a MVA that involved a semi-truck that had its saddle tank damaged, causing diesel fuel to spill on the roadway. The rescue crew utilized the Haz Mat unit to control the leak and offload the remaining fuel into a 55-gallon drum. Due to a thunderstorm that rolled through the area, which also contributed to the accident, it made it difficult for the crew to use fuel pads to absorb the fuel from the roadway because the roadway was wet from the rain.



- On 8/27/25 Ladder 57 was requested mutual aid into Clinton-Warren Joint Fire District fore reported structure fire on 3100 Gum Grove Dr. Crew assisted with fire suppression and overhaul of the structure.



- On 9/23/2025, Station 58 was alerted to respond across the street to the Kings High School soccer field for an MVA in which a vehicle struck the light pole for the field, and the vehicle rolled multiple times on the soccer field. 58's crew arrived on scene to find the vehicle on its top with the driver still trapped inside the vehicle. School officials and coaches were attending to the driver. The 58's crew rapidly extracted the patient from the vehicle and transported the patient to West Chester Hospital for trauma evaluation. At the time of the accident, soccer practice was in session, and luckily, no students or coaches were injured.



- In the early morning hours on 9/30/2025, Rescue 57 was dispatched as mutual aid into the Loveland-Symmes Fire District to 219 Chestnut St. Units arrived on scene to find the second floor and roof well-involved on the second floor and through the roof of a two-story vacant building. The building has been vacant for twenty-plus years. The structure was listed as a no-go structure due to the deterioration. Rescue 57 crew assisted with fire suppression from the exterior of the structure. Portable ground ladders and aerial ladders were used to assist in extinguishing the fire.
