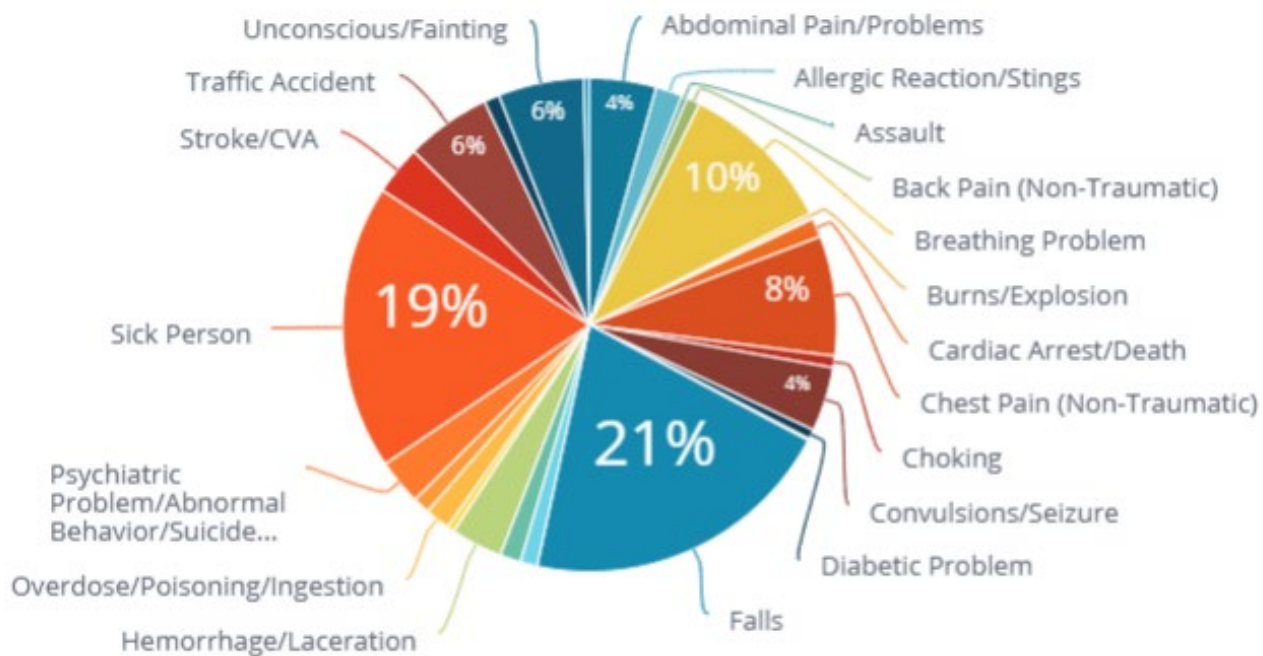
Chief Eisele,

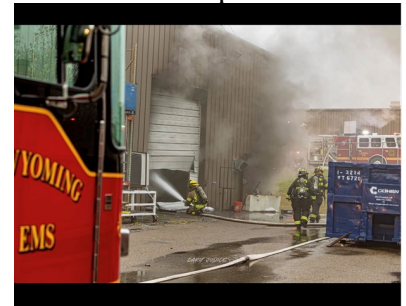


Noteworthy Incidents Unit Two Responded On During Fourth Quarter:
