### Planning and Zoning

- Staff issued 86 zoning certificates (54 residential and 32 commercial). It should be noted approvals include new homes, accessory structures, signage, additions, interior/exterior modifications. Minor PUD Modifications, and Zoning Verification letters.
- Staff performed final inspections on 11 residential properties for zoning compliance with approved plans.
- Staff received 20 formal complaints and investigated all 20 in the 3rd Quarter which resulted in 11 violation notices being issued to property owners. It should be noted that 9 of the formal complaints received were either cleared prior to notices being issued, no zoning violation was found, and/or not zoning related and could not be addressed by the Planning & Zoning Department.
- The Board of Zoning Appeals reviewed three (3) cases in the 3rd Quarter. Two variances involved residential properties and one involved a proposed Home 2 Suites on Bardes Road.

- Current Staffing is down by only one deputy. This line is being held for the future K9 position. The intent is to conduct a selection process in early 2024.
- Deputies Bryon Watson, Levi McClellan, Jared Burson have been added to fill deputy vacancies.

#### **Training**

The Sheriff's office and DTFR collaborated to conduct their annual RTF (Rescue Task Force) training at Columbia Intermediate School. This joint training initiative ensures that both EMS (Emergency Medical Services) and law enforcement personnel are well-prepared to respond effectively to these types of incidents. This proactive approach to training enhances their readiness and coordination during critical incidents.

Multiple training sessions took place at the training tower, notably the department's annual live burn training. This type of training exercise offers firefighters hands-on experience in real-life fire scenarios, enhancing their skills and preparedness.


### Fire Department

These existing nozzles were still in service from the Mason Deerfield Joint District. After thorough evaluation, it was concluded that the Chief XD nozzle aligns perfectly with the department's operational requirements, and it was chosen by the committee as a suitable replacement option. This decision ensures improved equipment standardization and enhanced firefighting capabilities within the department.

### Public Works - Road and Bridge

#### Quarter #3 milestones for the Service Department are detailed below.

#### Road Work

- Crews continue to mow and weed eat Township Right-of-Way (ROW).

- Completed Dally Park inspections and all cleaning required at restrooms and pavilions. (Weekly, including weekends) Crew members took equipment for a touch-a-truck event at the Compass School

- Our service department made repairs were made to 16 Catch Basins. Staff installed 60 FT of 12" pipe and 40 FT. of 30" pipe in the right-of-way. The Service Department also installed 40 FT. of 36" pipe at Roberts Park.
- A new concrete pad and a new shelter was built by our service department at our Dog Park
- The park pathways were trimmed by our team during Q3.

### Deerfield Regional Storm Water District

- Staff fielded 23 stormwater calls and received 6 Requests for Assistance (RFA) during 2023 Q3.
- Staff managed 13 stormwater-related Improvements, of which 3 projects were completed, with another 10 In various stages of design or construction.
- The stormwater improvements at the Meadow Dr. and Green Haven Way Intersection have been bild out, WG Stang LLC has been selected as the contractor. They anticipate construction to begin in mid-November. Once complete, the improved drainage system should greatly reduce the chance of roadway flooding in the future.
- The District is working with the Deerfield Township Trustees to improve stormwater infrastructure as part of the Kings Mills Improvement Project. This cooperative project ensures that both the roadway and storm sewer upgrades are completed at the same time. Phase III is anticipated to begin in early 2024,
- A study and evaluation of the stormwater and drinking water infrastructure in the Loveland Park area is underway and will continue into 2024. When complete, the plan will guide the various agencies as they make improvements in the area.
- The Deerfield Township Trustees have begun a project to protect Kings Mill Road, which is suffering from extreme stream bank erosion upstream of the Old 3C highway bridge. If left unchecked, the roadbed will fail, and the road will close. The Trustees contracted with Channel Maintenance Systems because of their extensive experience using natural streambank stabilization methods throughout the State of Ohio. By anchoring cut vegetation to the bank, the river will slow enough to deposit sediment and build up the streambank. Work will be completed in the fall of 2023.





Service Department - Parks
