Planning and Zoning

- Staff issued 64 zoning certificates (39 residential and 25 commercial). It should be noted approvals include new
 homes, accessory structures, signage, additions, and interior/exterior modifications.
- Staff performed final inspections on six residential properties for zoning compliance with approved plans.
- Staff received and investigated 12 formal complaints in the 1st Quarter which resulted in five violation notices being
 issued to property owners. It should be noted that seven of the formal complaints received were either cleared
 prior to notices being issued, or no zoning violation was found. Consequently, they could not be addressed by the
 Planning and Zoning Department.
- The Board of Zoning Appeals reviewed four cases in the 1st Quarter. Three of the variances involved residential
 properties and one involved the Rivers Crossing Church.

Training

We started the year off getting back to our standard aggressive training schedule. The first quarter of 2023 saw the construction and completion of our joint training facility with Hamilton Township. This is a very well designed facility that will last the employees of Deerfield Township for decades to come. Crews have already conducted seasoning burns in the structure to season the burn room panels. Moreover, a ribbon cutting was held on March 27th with elected and appointed officials from both townships for the official opening of the tower.

We are currently waiting for the asphalt at the tower, which is anticipated to be completed by early May. We also are moving a 4" water main and hydrant to the site from Nunner Road. These are additional expenses; however, they are necessary to ensure the best possible training on the site. We anticipate that this work will be completed in the summer. A joint training calendar has already been established to aid in the scheduling of the tower.

In other training news, our monthly trainings have increased to four per month. This year we conducted our bi-annual CPR and ACLS classes. These were done in partnership with UC West Chester. We also conducted the in-service training of our Paratech Hydro-Fusions. These struts will greatly increase our ability to lift and hold loads up to 10 tons each. They have been placed on Rescue 57.

We ordered 14 sets of turnout gear as our annual replacement schedule. The turnout gear matches our department specification and is due to be delivered this spring. Additional t-shirts have also been ordered for stock. Our stock program has been working out well and has cut down on order requests from staff. We also received new uniforms for our promoted employees and had the Class A uniforms updated. Lastly, new fire helmets were purchased for both promotions and stock as part of our annual replacement schedule.

Stigler Supply has restocked our central supply of station items. These items are tracked by Firefighter Bentley at Station 58. We don't have any large budget items for 2023, so we will just be maintaining what we have for now to include the extractors.

Fire Equipment

Fire equipment for the new rescue has been purchased and placed into storage for now. This includes another Grip Hoist, Paratech adapters, chains, and rigging hardware. We also replaced the G2 multi-gas meter on Rescue 57 since it was cheaper than repairing the old one. Lastly, we ordered 400' of 2" hose for Engine 57 as the unit is 100' short and that is our original 2" hose for the department.

A new E-Force spreader and cutter have been ordered for Rescue 57 as well. These are larger units and gen-3. Our current E-Force tools are gen-1 which will be rotated up to Engine 58 due to the amount of mutual-aid accidents that unit is making.

SCBA's

We have ordered the remainder 25 SCBA RIT pouches for our staff and medic units. This completes our RIT pouch replacement for all 50 SCBA's. Each SCBA compressor has had its bi-annual maintenance completed. The OOS fill station at Station 57 has been repaired.


Our medic units responded to 806 emergency medical calls during the first quarter. During the first quarter there were no significant EMS incidents to report.


AED and Stop the Bleed Kit Project:

The Automated External Defibrillator (AED) and Stop the Bleed Kit project was assigned to the EMS division late last year. This project was to evaluate several different AED units and the locations needed within the Township's owned facilities and parks. The AED unit the EMS division decided on was the Lifeline AED which is perfect for a layperson. This unit will provide step-by-step instructions that are loud and clear to understand, along with visual instructions to place the pre-connected defibrillation pads onto the patient.

Twelve locations were identified for needing AED units and Stopped the Bleed Kits. Such locations were Administration Building, Trustees Council Chambers, Public Works Building, and several parks such as Cottell and Kingswood Park. The AED storage cabinets and stop-the-bleed kits have arrived, and the cabinets have been installed at the locations that were initially identified. The AED units are currently on a nationwide back order, and we are hoping to hear back soon from our vendor when the AED units will be available for delivery





Public Works - Road and Bridge

Quarter #1 milestones for the Service Department are detailed below.

- Our Service Department responded to three snow events clearing a total of 12 inches of snow from Township roads
- Inspected and made necessary repairs/replacements in Sign Zones (1-3).
- Completed tree trimming along township roads for our annual paving plan.
- Staffed numerous funeral events in assisting the Cemetery Department.
- Staff performed six sweeps of all zoning signs throughout the 1st quarter.
- Completed our guardrail inspection, staff made all necessary repairs.
- Responded to all drainage issues, potholes, and other miscellaneous calls from residents. Service Department staff replaced wood decks on two trailers.
- Staff utilized our hot box on multiple roads through out the Township for pothole maintenance.
- Staff built 25 new Road Closed barricades with HIP reflective signs and tape.
- We repaired, rebuilt and hand painted six five foot tall Easter eggs witch were placed in various locations at Kingswood Park.
- Our service crew repainted and applied HIP striping on trail bollards at all of our parks
- We built seven new garden boxes for the community garden at Carter Park for a total of fifteen.
- Our crew built and installed four new archery shelters to replace the old ones at Carter park.
- On two separate events the Little Miami River crested over Davis and Old Kings Mills Rd our service crew set out High Water and Road Closed signs. When the river was at a safe level the roads were cleaned and signs were removed.
- Installed residents pipe on Aster Rd., still working on several other residential pipes and ditches.



Public Works - Administration

- Street Light Inspections Staff inspected zones 8 thru 2 for defective street lights. 14 streetlights were reported to be repaired.
- 2023-01 Annual Resurfacing Project Staff has prepared estimate and bid documentations for project. Project was awarded to Barrett Paving Materials Inc. Work is set to commence in late March. Project includes roadwork patching in various areas throughout the Township. Resurfacing to take place in Heritage Green and Woodfield subdivisions.
- 2019-03 Kings Mills Improvement Project Ford Development Inc. is on schedule to be completed by late May with Phase II.
- Phase III easements will be sent out to residents in April. Utility coordination meeting will begin in mid March.
- 2023-02 Landscaping Maintenance Project -Staff has prepared estimate and bid documentations for project. Project was awarded to Degree Landscaping. Spring cleanup and mulch installation to began at the end of March.
- Staff hosted the March PWOSO meeting at Deerfield Township.
- Preparing documents for Phase III and Phase IV of the Kings Mills Project for the OPWC grant.
- Continuing to prepare for the Kings Mills Improvement project Phase III Project to bid in June 2023.
- Continuing collaboration with WCTID for the future construction of a pathway on Irwin Simpson and the Improvement Columbia Rd.
- Completed monthly safety training for all service personnel.
- Staff preparing for work to be completed on Dais, Rich and Primrose Waiting on final plans from LIB engineering. Work to take place this
- Working with CT Consultants for the kingwoods connection path to 71 Bridge.
- Staff continues to collaborate with Warren County Engineer's regarding the King Ave Turn Lane and Roundabout.
- Staff is working with Kleingers Group for the street scape design and landscaping improvements along Mason-Montgomery and other various locations.



Deerfield Regional Storm Water District

- Staff fielded 52 storm water calls and received 9 Requests for Assistance (RFA) during 2023 Q1.
- Staff managed 14 stormwater related improvements, of which four projects were completed with another 10 in various stages of design or construction.
- The 2022 Ohio EPA stormwater annual report was recently submitted. This report details the past years accomplishments and tracks the measures used to protect water quality and comply with EPA's permit requirements.
- The District is working with the Deerfield Township Trustees to improve stormwater infrastructure in Phase II of the Kings Mills Improvement Project. This cooperative project ensures that both the roadway and storm sewer upgrades are completed at the same time.
